### HIC Memembrship Article VI

#### Section 1 - Categories of Members:

A. Regular Members: All Muslims who reside in the Tennessee Valley either on permanent or temporary basis and are in full agreement with the purpose of the Association, shall be eiqible to become Regular memeber.

B. Voting Members: Every regular member of the Association who is eighteen years of age or older who completes a registration form and pays the membership dues shall become a Voting Member of the Association.

#### Section 2 - Voting Rights:

Only voting members shall have the voting rights. Each voting member shall be entitled to only one vote. A member, whose dues are in arrears, loses the right to vote as long as he/she is in such arrears. New members shall not have voting rights until 90 days have elapsed since their joining and payment of dues. Dependents of current voting members must also abide by the 90 days waiting period to exercise their voting privileges.

#### Section 3 - Dues:

Annual membership dues shall be determined and may be changed from time to time by the Board of Directors.
